RESOLUTION OF THE CALAVERAS COUNTY RESOURCE CONSERVATION DISTRICT (CCRCD) BOARD OF DIRECTORS OF CALAVERAS COUNTY, STATE OF CALIFORNIA

Resolution Number: 2021-02

WHEREAS, the Pine Ridge Fuelbreak, located in central Calaveras County from the Calaveras Reservoir to Summit Level Road, has an approved CEQA package, and is ready for implementation with funding from the Sierra Nevada Conservancy, entails approximately 144 acres with a proposed budget of approximately \$328,000;

WHEREAS, the Forest Meadows fuels reduction project, located along Highway 4 between the Forest Meadows subdivision (includes the Wylderidge subdivision) and Darby Russell Road, ties into the CCRCD "Murphys to Forest Meadows" project. It is proposed to be a CAL FIRE CCI implementation grant (CEQA must be completed within one year) and entails approximately 162 acres with a proposed budget of approximately \$485,100.

NOW, THEREFORE BE IT RESOLVED that the Calaveras County Resource Conservation District, if either or both of these projects are approved for funding by SNC (Pine Ridge Fuelbreak) or CALFIRE (Forest Meadows Fuels Reduction Project):

- 1. Will serve as CEQA Lead Agency for the Forest Meadows project;
- 2. Will serve as Fiscal Sponsor for the Forest Meadows project;
- 3. Will serve as Fiscal Sponsor for the Pine Ridge project;
- 4. Appoints Gordon Long, Executive Director, or a designee, to be signee of one or both of these approved, executed contracts.



<u>Calaveras-Amador Forestry Team –</u> the "CalAmTeam"



The CalAmTeam formed in 2014 to protect local communities from catastrophic wildfire. The CalAm Team provides expertise and effort towards improved land management for the benefit and protection of Amador and Calaveras County residents offering expertise in forest practice and management, GIS, grant development, environmental assessments, project management and monitoring. With a diverse background in natural resources, we (1) Develop and secure grant funding (over \$20 million to date); (2) Provide planning and coordination of strategic fuels reduction projects; (3) Deliver consulting services to Counties/FSCs/RCDs/HOAs/Water Agencies; (4) Effect public education and outreach; and (5) Build capacity - train local grant writers, fund the John Hofmann Memorial Scholarship



<u>John Hofmann</u> - IN MEMORIAM - from Pine Grove, CA — A forest engineer, 1974 graduate from the University of Idaho, and legislative advocate/analyst, John worked over 45 years for private industry and county governments, proposing innovative solutions in the field, and to state and federal agencies and legislatures. John was a natural resources consultant to the Amador County Board of Supervisors and a member of the planning committee for the Amador Calaveras Consensus Group.

Raised in Richmond CA, Pat spent holidays/summers at the family gold mine in Glencoe. After college graduation he pursued a career in research on the epidemiology, immunology and chemotherapy of tropical diseases that included post-doctoral studies at the London School of Hygiene and Tropical Medicine, research at the Walter Reed Institute of Research in Washington DC and field studies in tropical Tanzania, Borneo, Panama and Brazil. His contributions were often recognized, but his most coveted award was the "Brazilian Army Medal of the Peace Maker", the highest honor bestowed on foreign nationals by the Brazilian Army. In 1994 Pat retired in Glencoe for a life of community service: Little League manager, firefighter/EMT on the Glencoe/Rail Road Flat Fire Department, Commissioner for Calaveras Parks & Recreation, local historian, and member of the Calaveras Consensus Group. Pat was the 2014 Calaveras Senior Volunteer of the Year.
