Introduction: S. Beckman introduced our two new board members – Tyler Robertson and Kent Lambert.

Partners: Ms. Parsons reported NRCS has a new Range Conservationist. She updated us on the Environmental Quality Incentives Program (EQIP), the Agricultural Land Easement Program (ALE) and Pollinator project with Zerces Society.

Old Business:

- 1. Update on Projects: reported on by E.D. Gordon Long
 Received five applications for the CEQA contract for the Murphys to Forest Meadows project. The
 contractor hired is Ed Struffenegger. His planning work will be done by April then we will do
 requests for proposals for mechanical contractors to treat approximately 730 acres. The 730 acres
 will be broken into sub-units. Full completion is slated for the end of 2022. Some will be done by
 hand, while most will be done with mastication machines.
- 2. Building Sale S. Beckman first brought up to speed the new board members (Robertson and Lambert) with some background information of the decision to sell. He then reported on the next steps to be taken. It was recommended we find a specialist is selling government land. It was noted we can sell the building to the general public, but it must be offered to other government entities before it can be sold publicly. We have to follow the Rules of 2020 Surplus Lands Act. S. Beckman will continue his research.

New Business:

3. New grant opportunities – G. Long reported he is working on getting Mariposa on board to join our Amador/Calaveras/Tuolumne RCD group.

Future projects ideas include existing fuel break projects in each county that need maintenance; home hardening from wildfire program; seedling or seed distribution program; SNC grant to use for recreation trail; internment of woody biomass into soil for carbon sequestration.

The central mandate of this Project is to remove woody fuels along important community access roads near PG&E facilities in the wildlland urban interface (WUI) along private roads in the communities of Rail Road Flat, Mountain Ranch, Sheep Ranch, and Swiss Ranch, Calaveras County. These communities and access roads were hit hard by the 2015 Butte Fire. The resprouting of brush and oaks have been overwhelming in these areas. These private roads are not maintained by County or State. This work will provide:

Ingress/Egress Access Roads

- 1. Increased ingress/egress along chosen roads
- 2. Increase needed horizontal and vertical spacing of evacuation corridors, and 3. Provide increased fire-safe regions for firefighting crews and equipment. Chosen road segments will be cleared of brush and small trees (10" and smaller at DBH) for 20 feet on both sides of the road. All work will be accomplished on targeted roads that are within 1000 feet of PG&E facilities (distribution lines). This Project adheres to the 2016-2017 Calaveras County Community Wildfire Protection Plan (CCCWPP). According to the CCCWPP, there are many communities and and neighborhoods identified as prioirty areas where roadside ingress/egress fuels reductions would be beneficial, including ones we chose for this grant. All the cummunities identifed identified here are considered "Communities At Risk" by CALFIRE. These portions of Calaveras County have been impacted over the last nine years by drought, beetle infestations, human caused ingnitions, and high erratic winds during the fire season, in addition to the 2015 Butte Fire. Work will be accomplished by masticaton conducted by heavy equipment operators and hand crews. Debris will be chipped and left on the landscape to protect against erosion and deter flash fuel and brush regeneration. If local residents request chip material, we would leave material in piles for easy distribution.

The Calaveras County RCD will distribute and make available PG&E literature describing the work, and its benefits to landowners and residents.

In 2018, PG&E initiated a program in many regions of their Service Area to increase facility clearance. Where possible, we would extend facility clearance in these higher risk zones that PG&E has deemed important. These private roads are often the only evacuation routes available to residents when a natural disaster occurs. Since these roads are privately maintained, they do not recieve the attention that is warranted to maintain proper road-side clearance for evacuation routes and for fire-fighting activites. The CCRCD has shown our ability to adminster and implement a successful PG&E grant.In 2018, 2019, and 2020 PG&E granted the CCRCD fuels reduction grants to remove fuels along private roads with PG&E infrastructure. All three projects that were
